Dear Friends and Colleagues:

It is the first business day of Summer 2015, and we are approaching the mid-point of the calendar year, as well as the current term of the Officers and Board members of the chapter.

For the first half of 2015, the chapter ran a total of 3 classes, including the very successful Appraiser Qualifications 15 (AQ15) a required class to achieve NY State Certification; thank you Frank Notaro MAI

SRA for your prodigious efforts to bring this class to the Chapter.

In addition, we had several very successful seminars that afforded our members and attendees the opportunity for a concentrated learning experience in the framework of our monthly dinner meetings. If you haven't attended a monthly meeting during the first half of the year, I encourage you to take the opportunity to do so this fall.

While we may be enjoying the onset of more languid summer days, the Chapter continues its work of providing education and career development opportunities to the membership. As a part of our summer program the chapter is proud to offer the new 4-hour seminar in '*Contract or Effective Rent*' on June 23<sup>rd</sup>. Following that, on July 24<sup>th</sup> the chapter will offer the 7-Hour National USPAP Update seminar, a bi-annual requirement for your NYS Certification renewal.

Also coming up on August  $10^{th} - 14^{th}$  will be the new '*Review Case Studies Course*' a 30 hour class over 4 days presented with David Lennhoff as the instructor. This course is *required* to meet the designation requirements of candidates who are pursuing the new AI-GRS designation and are not designated as MAI members.

Chapter officers are often asked why there are not more courses offered at the chapter level, so that as a candidate or member, students do not have to incur the additional cost of travel and lodging to meet the course requirements for a designation and recertification.

The offering of a national course at a local chapter is challenging in part because the fixed costs for presenting the course are substantial and the Chapter's financial exposure sizable, should we not meet a minimum number of paid attendees. This process has recently been made more difficult because National has set a cut off date after which the chapter cannot cancel the course. Therefore, we would have to run the course *irrespective of the financial impact* to the chapter.

It was with this in mind that over the past several weeks, our chapter executive, Francine Morgenstern, members of the Education Committee and myself, have reached out to many of the

prospective attendees for the Review Case Studies Course, to confirm<sup>\*</sup> their intent to attend the course, and many of you did. It is because of your responses, that this class will be able to run.

Thank you on behalf of the chapter and our fellow members and candidates, for stepping up early, and affirmatively when called upon. Seats are still available for the August 10 /14 Course, please contact Francine Morgenstern to sign up.
